General Information

Am I Eligible

All full-time Domestic, International students and visiting scholars are eligible for coverage under the Policy. Eligible students are required to have health insurance coverage and will be automatically enrolled in the Student Health Insurance Plan at registration and the premium contribution will be added to the student's tuition fees unless proof of comparable coverage is provided by completing the waiver.

International students and visiting scholars are defined as having a current passport or student visa and are temporarily residing outside their home country while actively engaged in education or educational activities or research related activities at the University.

Dependents

Insured Students who are enrolled in the Student Health Plan may also enroll their eligible Dependents.

How Do I Waive?

To Waive:

- Go to www.wellfleetstudent.com.
- Search **Northwest Nazarene University**
- Click the waiver tab and proceed as directed. You must fill in all of the required information on the waiver form. If any information is missing, your waiver will not be accepted.
- Click submit and review the information being provided is accurate.
- When your online waiver form is successfully submitted you will receive a confirmation e-mail.

The deadline to waive coverage for Annual coverage is 8/30/2022.
