1. STUDENT TAX RETURN FILERS

As part of federal student aid eligibility, students will be required to consent and approve sharing and importing income and tax information from the IRS to the FAFSA form, even if the attempt to obtain or use such data. A 2023 IRS Tax Return Transcript may be obtained through:

• Get Transcript by MAIL/ONLINE: Go to www.irs.gov, click "Get Your Tax Record." Click "Get Transcript by MAIL" or click "Get Transcript ONLINE". Make sure to request the "Return Transcript" and NOT the "Account Transcript."

To use the Get Transcript Online tool, the user must have (1) access to a valid email address, (2) a text-enabled mobile phone (pay-as-you-go plans cannot be used) in the user's name, and (3) specific financial account numbers (such as a credit card number or an account number for a home mortgage or auto loan). The transcript displays online upon successful completion of the IRS's two-step authentication.

- **Automated Telephone Request:** 1-800-908-9946. Transcript is generally received within 10 business days from the IRS's receipt of the telephone request.
- **Paper Request Form:** IRS Form 4506T-EZ or IRS Form 4506-T. The transcript is generally received within 10 business days from the IRS's receipt of the paper request form.

2. STUDENT TAX RETURN NONFILERS

ALL NONFILERS MUST provide documentation from the IRS, or other relevant tax authority, dated on or after October 1, 2024 that indicates a 2023 IRS income tax return was not filed with the IRS, or other relevant tax authority.
